ORDER

For the purposes and in pursuance of the provisions contained in Section 13 of the NCTE Act, 1993, NCTE Headquarters conducted inspection of the Ch. Ishwar Singh Mahila Shikshan Mahavidyalaya, Fatehpur, Pundri, Kaithal - 136026 on 21.07.2003 and after having received the report / findings from the inspection team and seeking response of the institution on the deficiencies reported by the inspection team, the same were forwarded to the office of NRC to take further necessary action in accordance with the provisions of the NCTE, Act, Rules, Regulations etc. The deficiencies pointed out are as under :-

Four out of seven lecturers appointed by the Institution do not possess NET (1) qualification.

The list of teaching staff has not been countersigned by the registrar of the (ii) affiliating University.

The number of practice teaching days are shorter of the requirement laid down (iii) in the NCTE norms.

The ET lab does not have adequate number of electronic publications on (iv) education.

Most of the teaching staff is being paid consolidated salaries in cash which is (Y) not in accordance with the NCTE / Central / State / UGC guidelines.

- AND WHEREAS, the said report of the inspection team was placed before the NRC in its 87th meeting. Having considered the same, the Committee decided that a Show Cause Notice be issued to the institution under Section 17(i) of the NCTE Act, 1993. Accordingly a Show Cause Notice dated 09.02.2005 was issued to the Institution, communicating therein the deficiencies observed by the visiting team on inspection made by it under Section 13 of the NCTF. Act, 1993, providing opportunity of making representation against the proposed action.
- AND WHEREAS, the matter was considered by the NRC in its 89th meeting wherein the committee noted that the reply submitted by the institution is vague and evasive and deficiency number (i), (iv) and (v) as communicated in Show Cause Notice still exist. Having considered the entire matter, including the deficiencies and their impact on the quality of teaching training / education and other being satisfied that the institution has violated norms and standards faid down under the Rules, Regulations and Orders made or issued under the Act as well conditions subject to which recognition / permission was granted to the institution for the B.Ed. course have decided to withdraw recognition of Ch. Ishwar Singh Mahila Shikshan Mahavidyalaya, Fatehpur, Pundri, Kaithal - 136026, Haryana for running B.Ed. Course with effect from the end of the current academic session 2004-2005.
- AND THEREFORE, the recognition of Ch. Ishwar Singh Mahila Shikshan Mahavidyalaya, Fatehpur, Pundri, Kaithal - 136026 for B.Ed. Course was withdrawn from the end of the current academic session i.e. 2004-2005 vide Order No. F.NRC/NCTE/F-3/HR-168/731-740 dt, 28th April, 2005.

- 5. AND WHEREAS the institution filed on Appeal under Section 18 of NCTE Act, 1993, before the Appellate Authority of NCTE. The Appellate Authority vide order No. 89-86/2005-Appeal dt. 27.07.2005 reversed the order dt. 28.04.2005 of NRC, Jaipur with the condition that within three months further inspection be done to see that it is fulfilling all the norms of NCTE.
- AND WHEREAS, the inspection of the institution was conducted under Section 17 of NCTE Act, 1993 on 16.06.2006;
- 7. AND WHEREAS, the entire matter was considered by the NRC in its 105th meeting wherein the committee noted that the deficiencies have not been removed by the institution. Having considered the entire matter, including the deficiencies and their impact on the quality of teaching training / education and other being satisfied that the institution has violated norms and standards laid down under the Rules, Regulations and Orders made or issued under the Act as well conditions subject to which recognition / permission was granted to the institution for the B.Ed. course, decided to withdraw recognition of Ch. Ishwar Singh Mahavidyalaya, Fatehpur, Pundri, Kaithal 136026, Haryana for running B.Ed. Course with effect from the end of the current academic session 2005-2006.
 - 8. As a result of this order, Ch. Ishwar Singh Mahila Shikshan Mahavidyalaya, Fatchpur, Pundri, Kaithal 136026 shall discontinue B.Ed. teacher training course immediately after the academic session 2005-2006 and the concerned University or examining body shall cancel affiliation of the institution in accordance with this order with effect from the end of the current academic session 2004-2005 as provided under Sub-Section (3) of Section 17 of the National Council for Teacher Education Act, 1993.
 - 9. The qualification in teacher education obtained porsuant to that course or training or after undertaking a course of training in the said institution after the academic session 2004-2005, shall not be treated as valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other educational body aided by the Central Government or any State Government as per Sub-Section (4) of the Section 17 of NCTE Act, 1993.
 - 10. Further, if the institution is not satisfied by this order, it can prefer an appeal before NCTE, Headquarters against this order under Section 18 of NCTF. Act, 1993, within 60 days of the date of issue of this order. The guidelines for appeal are enclosed.
