

ORDER

WHEREAS IN terms of Section 15 (1) of the NCTE Act, 1993 GURU RAM DASS B.ED. COLLEGE, DAV COLLEGE ROAD, VILL-CHAK ROOM WALA, PO-JALALABAD (W) -152 024 DISTT- FROZEPUR, PUNJAB has submitted an application (code No.03193) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting E.T.T. Course of 2 year duration with an annual intake of 50 (Fifty Only) students.

- 2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to GURU RAM DASS B.ED. COLLEGE, DAV COLLEGE ROAD, VILL-CHAK ROOM WALA, PO- JALALABAD (W) -152 024 DISTT- FROZEPUR Punjab for conducting E.T.T. Course of 2 year duration with an annual intake of 50 (Fifty Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfilliment of the following:
 - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 4. The Principal is going to complete 60 years by August 2008 so the institution must appoint another principal within a year by the end of August 2008 and documents of the principal in terms of his qualifications and experiences along with the affidavit with regard to selection committee as prescribed by the NCTE and the joining report needs to be submitted after the appointment failing to which NCTE NRC will take appropriate action as per norms and regulation.
- Further, the recognition is subject to fulfillment of all such other requirements
 as may be prescribed by other regulatory bodies like UGC and the State Government
 etc, wherever applicable.
