#### ORDER

WHEREAS In terms of Section 15 (1) of the NCTE Act, 1993 I. P. College of Education, Rithal Road, VIII & P.o-Jassia, Tehsil & Distt-Rothak, Haryana has submitted an application (code No.03804) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting M.Ed. Course of One year duration with an annual intake of 25(Twenty Five Only) students.

- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to I. P. College of Education, Rithal Road, VIII & P.o-Jassia, Tehsil & Distt-Rothak, Haryana for conducting M.Ed. Course of one year duration with an annual intake of 25 (Twenty Five Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
  - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
  - (ii). The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements
  as may be prescribed by other regulatory bodies like UGC and the State Government
  etc, wherever applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report
  at the end of each academic year along the statement of annual accounts duly audited
  by a Chartered Accountant.
