 - (i) The Institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern **Egginal Committee.
 - (ii). The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements
 as may be prescribed by other regulatory bodies like UGC and the State
 Government etc, wherever applicable.
