WHEREAS in terms of Section 15 of the NCTE Act, 1993 , G.S.R.M. - 3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCIE Act, 1993, the Northern Regional Committee hereby grants recognition to G.S.R.M. Memorial Degree College, D-6, Industrial Estate, Sarojini Nagar, Kanpur Road, Lucknow - 226008, U.P. for conducting B.P.Ed. Course of One year duration with an annual additional intake of 50 (Fifty Only) (Existing 50 + Additional 50 = 100) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
  - The institution shall, within one month of the receipt of recognition order, (i) convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
  - The institution shall comply with the various other norms and standards (ii) prescribed in the NCTE regulations, as amended from time to time..
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc. wherever applicable.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
