

ORDER

WHEREAS In terms of Section 14 (1) of the NCTE Act, 1993 S.D. - NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to 1993 S.D. Memorial College of Education, Near VIII Jondhr Chhal Road, Distt- Jhajjar, Haryana for conducting B.Ed. Course of one duration with an annual intake of 100 (one Hundred Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
 - The institution shall, within one month of the receipt of recognition (1) order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - The institution shall comply with the various other norms and standards (11). prescribed in the NCTE regulations, as amended from time to time.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.
