- NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to VIVEKANAND GRAMODYOG P.G. COLLEGE, DIBIYAPUR, DISTI. - AURAIYA, U.P. for conducting B.Ed. Course of Secondary (level) of one year duration with an annual intake of 100 (One Hundred) students from the academic session 2008-2009 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following.
 - The admission of students shall be done only after affiliation by the examining body (i) before the commencement of the academic year and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic year 2008-2009 failing which the recognition will be deemed to be for the next academic year i.e. 2009-2010. (ii)

Formal orders for recognition/permission will operate for 2008-2009 only if the requirement of 180 teaching days in the session would be fulfilled as per calendar of the University/affiliating body.

The institution shall, within one month of the receipt of recognition order, convert the (iii) endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

The institution shall comply with the various other norms and standards prescribed in the (iv) NCTE regulations, as amended from time to time.

The institution shall make admission only after it obtains affiliation from the examining body (v): in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable
