WHEREAS in terms of Section 15 (1) of the NCTE Act, 1993 I.P. - 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to 1993 I.P. College of Education, Rithal Road, Village & Post-Jassia, Distt- Rohtak, Haryana for conducting CPED intake of one year duration with an annual intake of 50 (fifty Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
  - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
  - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements
  as may be prescribed by other regulatory bodies like UGC and the State
  Government etc, wherever applicable.
