## ORDER

This order is in continuation of our letter no. F.NRC/NCTE/F-7/HR-946/2006/37017 dated 30.01.2008. As per the decision of the Northern Regional Committee 124<sup>th</sup> Meeting held on 21 - 22 January, 2008, the Institution has been refused recognition, whereas inadverterly a show cause notice was Issued vide aforesaid letter.

- WHEREAS Ganga Sports College, Vill Dujana, Post Dujana, Distt. Jhajjar, Haryana under Dujana Education Society, Vill - Dujana, Tehsil - Beeri, Distt. -Haryana has applied for grant of recognition for C.P.Ed. Course of two years duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE
- AND WHEREAS the competent authority has constituted a Visiting Team to visit the Institution and the visiting team has since submitted its report.
- 4. AND WHEREAS in its 124th meeting held on 17 19 December 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 03.01.2008 to the applicant institution not fulfill the requirements and issued a notice on 03.01.2008 to the applicant institution under proviso to section 15 (3)(b) of the NCTE Act, 1993 therby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 5. AND WHEREAS, the applicant institution has submitted representation to Northern Regional Committee, NCTE vide letter dated 02.01.2008. The said representation of the institution as well as other documents and materials submitted by the institution alongwith VTR and videography were again duly considered by the NRC on 21 22 January, 2008 which vTR and videography were again duly considered by the NRC on 21 22 January, 2008 which came to the consideration that recognition to the said institution be refused for the following reasons:
  - (I) The builtup area for proposed C.P.Ed. Course is not sufficient and less than the size as prescribed NCTE Norms.
- Now therefore recognition to Ganga Sports College, Vill Dujana, Post Dujana, Distt. Jhajjar, Haryana for C.P.Ed. course under section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
