ORDER

WHEREAS, Modern Indian College of Education, Vill- Pall, Post- Kund, Tehsil- Rewari, District- Rewari, Haryana, had applied for grant of recognition/permission (APN-04989) for B.ED Course of One Year(s) duration under Section 14(1) of the NCTE Act, 1993 to the NRC, NCTE on 8th Nov 2007.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the Institution and the Visiting Team which visited the Institute on 10th May 2008 has since submitted its report.
- 3. AND WHEREAS in its 131st 2nd meeting held on 21st Aug 2008 the Northern Regional Committee after considering the report of the Visiting Team, perusal of videography as well as other relevant materials furnished by the applicant institution is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 23rd Aug 2008 to the applicant institution under provision to section 14(3) (b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution make a written representation in this behalf.
- 4. AND WHEREAS the applicant institution had submitted representation dated 27th Aug 2008, to the NRC,NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the Northern Regional Committee on 29th -31st Aug 2008, which came to the conclusion that recognition/permission to the said institution be refused for the following reasons:
- (i) The covered area shown in the previously submitted map and now submitted map does not match. It is not clear how the covered area has been increased.
- NOW, THEREFORE grant of recognition/ permission to Modern Indian College of Education, Vill- Pall, Post- Kund, Tehsil- Rewari, District-Rewari, Haryana, for the Course in B.ED in terms of Section 14(3) (b) of the NCTE Act, 1993, is hereby refused.
