 - The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
 - Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc., wherever applicable.
