WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 KANCHAN SINGH BHOOLI DEVI MAHAVIDYALAYA, VILLAGE - BHIKHANAPUR, POST - SARVANKHERA, DISTT. - KANPUR DEHAT, U.P. has submitted an application (code No. APN02342) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.P.Ed. course of One year duration with an annual intake of 50 (FIFTY ONLY) stockerts on 7.10.2005.

- 2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the vixiting team in the form of report and ideography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary-PE teacher education Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the Programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
- 3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/parmission to KANCHAN SINGH BHOOLI DEVLMAHAVIDVALAYA, VILLAGE BHIKHANAPUR, POST SARVANKHERA, DISTT. KANPUR DEHAT, U.P. for conducting B.P.Ed. Course of Secondary-PE (level) of one year duration with an annual intake of 50 (FIFTY) students from the academic session 2008-2009 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions:
 - (i) The admission in the institutions so recognized for the academic session 2008-2009 shall be made only after affiliation by the examining body, before the commencement of the academic year and the admission of the students shall be completed well before the out off date prescribed by the examining body for the academic year 2008-2009, failing which the recognition will be deemed to be for the next academic year i.e. 2009-2010.
 - (ii) Formal orders for recognition/permission will operate for 2008-2009 only if the requirement of 180 teaching days in the session would be fulfilled as per calendar of the University/affiliating body. The decision of the University in this regard shall be final.
 - (iii) The institution shall, within one month of the receipt of recognition order, convert the andowment find and reserve fund accounts into Joint accounts to be operated along with an officer of the Northern Regimul Committee.
 - (iv) The institution shall comply with the various other norms and standards prescribed in the NCTT regulations, as amended from time to time.
 - (v) The institution shall make admission only after a obtains attitution from the examining hody in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory hodies like UGC, the State Government etc, wherever applicable.
