WHEREAS Baba Saheb Dr. B.R. Ambedkar College of Physical Education, Arttoni, Delhi Mathura Road, Agra, U.P. was granted recognition for running M.P.Ed. Course of two year duration with an annual intake of 20 seats with effect from the academic session 2000-2001 vide this office order no. F.No. F-3/UP-431/M.P.ED./2000/8028-35 dated 9.8.2000.

- 2. AND WHEREAS Now the institution has requested vide letter dated 21.9.2005 to change of correspondence address of the institution as Baba Sabhi Dr. Bhim Rao Ambedia. College of Physical Education, Pauri, NH-2, Near Raipura Jat Police Chowki, Tehsil & Distt: Mathura, U.P. in the newly constructed building.
- 3. AND WHEREAS matter was considered in NRC in its 100th meeting, the Regional Committee noted that the Institution has shifted to the new premises without approval from NRC NCTE, hence the Regional Committee decided to serve show cause notice under section 17 of the NCTE Act before withdrawing recognition for having shifted to the new premises without prior approval of NRC NCTE. The Show Cause notice issued to the institution on 17.2.2006. The institution has submitted reply dated 7.3.2006 and placed in NRC in its 104th meeting wherein the Regional Committee decided that fresh inspection of the institution under section 17 of the NCTE Act be conducted to verify the infrastructure, and instructional facilities available in the institution in the new premises.
- 4. WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 5. AND WHEREAS in its 127th meeting held on 27-29 March 2008 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 7.4.2008 to the applicant institution under provise to section 17(1) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 6. AND WHEREAS the applicant institution had submitted representation dated 8.5.2008 to Northern Regional Committee, NCTE. The said representation of the institut;—is well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC in its 132nd meeting held on 11-14 September 2008 which comes to the conclusion that recognition to the said institution be withdrawn from the end of the current running session, the reply submitted is not found satisfactory as regards to:
