- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to CH. KATAR SINGH MEMORIAL COLLEGE OF EDUCATION GOHANA SONEPAT, HARYANA for conducting B.ED. course of 1 year duration with an annual intake of 100 students under clause 7 (12) of NCTE Regulation dated 13th Jan 06 subject to fulfillment of the following:
 - (i) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc, wherever applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the Statement of Annual Accounts duly audited by a Chartered Accountant.
