WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 S.J. MAHAVIDYALAYA, VPO - RAMAIPUR, DISTT. - KANPUR NAGAR, U.P. has submitted an application (code No. April4719) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. course of One year duration with an annual intake of 100 (One hundred only) students on 13.9.2007.

- AND WHEREAS on seruriny/perusal of the application submitted by the institution, the 2 documents attached therewith, the affidget and the input received from the visiting team in the form of report and ideography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the Programme and has selected/appointed duly qualified teaching staff as per-NCTE norms.
- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to S.J. MAHAVIDYALAYA, VPO - RAMAIPUR, DISTT. - KANPUR NAGAR, U.P. for conducting B.Ed. course of Secondary (level) of one year duration with an annual intake of 100 (One Hundred) students from the academic session 2008-2009 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions:
 - The admission in the institutions so recognized for the academic session 2008-2009 shall (i) be made only after affiliation by the examining body, before the commencement of the academic year and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic year 2008-2009, failing which the recognition will be deemed to be for the next academic year i.e. 2009-2010.
 - Formal orders for recognition/permission will operate for 2008-2009 only if the (iii) requirement of 180 teaching days in the session would be fulfilled as per calendar of the University/affiliating body. The decision of the University in this regard shall be final.
 - The institution shall, within one month of the receipt of recognition order, convert the (iii) endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
 - The institution shall comply with the various other norms and standards prescribed in the (iv) NCTE regulations, as amended from time to time.
 - The institution shall make admission only after it obtains affiliation from the examining body (v) in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
