WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Amity Institute of Education, Amity University, Plot No. 4, Sector -125, Noida, Distt. - NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to Amity Institute of Education, Amity University, Plot No. 4, Sector -125, Noida, Distt. Gautam Budh Nagar, U.P. for conducting M.Ed. Course of P.G. (level) of one year duration with an annual intake of 25 (twenty five) students from the academic session 2008-2009 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:
 - The institution shall, within one month of the receipt of recognition order, convert the (i) endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee. (ii)
