WHEREAS in terms of Section 15 (1) of the NCTE Act, 1993 J.G. College of Education, C/O Bharat Sainik School, Hisar Road, Sirsa, Haryana, has submitted an application (code No.04929) to the Northern Regional Committee of NCTE for grent of recognition/permission for starting D.Ed. - 3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recugnition to **J.G. College of Education**, **C/O Bharat Sainik School**, Hisar Road, Sirsa, Haryana for conducting D.Ed. Course of two year duration with an annual intake of 50 (Fifty Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following
 - (I) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements
 as may be prescribed by other regulatory bodies like UGC and the State Government
 etc, wherever applicable.
