WHEREAS in terms of Section 15 (1) of the NCTE Act, 1993 Sant Jal ram Dass Memorial College of Education, V.P.O.-Pali (Narnaul-Dadri Main HighWay), Distt.-Mohinder Garh-123029, Haryana, has submitted an application (code No.04485) to the Northern Regional Committee of NCTE for grant of recognition/permission for additional intake in the existing D.Ed. Course of two years duration with an additional intake of 50 (Fifty Only) students.

- 2. - 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Sant Jai ram Dass Memorial College of Education, V.P.O.-Pali (Narnaul-Dadri Main HighWay), Distt.-Mohinder Garh-123029, Haryana, for conducting D.Ed. Course of two years duration with an additional intake of 50 (Fifty Only) students, thereby making the total annual intake of the institution to 100 (One Hundred only) (Two Unit) under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
