ORDER

WHEREAS In terms of Section 15 (1) of the NCTE Act, 1993 Gurudham College of Education, 6th K.M. Stone, Hisar Road, N.H.-65, V.P.O.-Khedar, Tehsli-Barwala, Distt.-Hisar, Haryana, has submitted an application (code No.04884) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting D.Ed. Course of two year duration with an annual intake of 50 (Fifty Only) students.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Gurudham College of Education, 6th K.M. Stone, Hisar Road, N.H.-65, V.P.O.-Khedar, Tehsil-Barwala, Distt.-Hisar, Haryana for conducting D.Ed. Course of two year duration with an annual intake of 50 (Fifty Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

- If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
