NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to RAM SINGH MAHAVIDYLAVA, NAGLA SIKANDAR, TUNDLA-ETAH ROAD, TEHSIL - TUNDLA, DISTT. - FIROZABAD, U.P. for conducting B. Ed. Course of One-year duration with an annual intake of 100 (One Hundred Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
  - The institution shall, within one month of the receipt of recognition (1) order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
  - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory-bodies like UGC and the State Government etc, wherever applicable.
