Course of two year duration with an annual intake of 50 (Fifty Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
- (1) The Institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (II) The Institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
