WHEREAS in terms of Section 15 (1) of the NCTE Act, 1993 R.S. Memorial College of Education, V.P.O.-Buana Lakhu, Ganaur Road, Tehsil-ISRANA, Distt.-Panipat-132103, Haryana has submitted an application (Code No. 05957) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting D.Ed. Course of two year duration with an annual intake of 50 (Fifty Only) students.

- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to R.S. Memorial College of Education, V.P.O.-Buana Lakhu, Ganaur Road, Tehsil-ISRANA, Distt.-Panipat- 132103, Haryana for conducting D.Ed. Course of two year duration with an annual intake of 50 (Fifty Only) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
