 - (i). The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a laint Account to be operated along with an official of the Regional Committee.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
