ORDER

WHEREAS in terms of Section 15(1) of the NCTF. Act, 1993 Rejendra Prasad P.G. College, Meerganj, Bareilly-243504, U.P. has submitted an application (code No. apn04334) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.P.Ed. course of One year duration with an annual intake of 50 (FIFTY ONLY) students on 09.05.2007.

- 2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and ideography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary-PE teacher education Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the Programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
- 3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to Rejendra Prasad P.G. College, Meerganj Bareilly-243504, U.P. for conducting B.P.Ed. Course of Secondary-PE (level) of one year duration with an annual intake of 50 (FIFTY) students from the academic session 2008-2009 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:
 - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - (iii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

- 6. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
