- 3. NOW, THEREFORE, in exercise of the powers vester under Section 15 (3) (a) of the NCTE Act, 1993, the Northern Regional committee hereby grants recognition/permission to Smt. Indira Devi College of Education, Village Sangipur, Post Radaur, Yamuna Nagar, Haryana for conducting D.Ed. Course of Elementary (level) of two year duration an annual additional intake of 50 (Fifty Only) (Existing 50 + Additional 50 = 100) student: from the academic session 2008-09 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:
 - (i) The institution shall, within one month to the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an office of the Northern Regional Committee.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - (iii) The institution shall make admission only Elect it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
