**ORDER**

WHEREAS Institute of Informatics and Management Sciences, Anuyogipuram, Near ILRM Medical College, Garh Road, Meerut, U.P. had applied for grant of recognition (UP - 2322) for M.Ed. course one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 121<sup>st</sup> (Second Sitting) meeting held on 16-17 September 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 22.9.2007 to the applicant institution under proviso to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

4. AND WHEREAS the applicant institution had submitted representation dated 13.10.2007 to Northern Regional Committee, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC on 21-22 January 2008 which came to the conclusion that recognition to the said institution be refused for the following reasons.

(a) **The built up area for proposed M.Ed. course is not sufficient and less than the size as prescribed in NCTE norms.**

5. NOW THEREFORE grant of recognition to Institute of Informatics and Management Sciences, Anuyogipuram, Near ILRM Medical College, Garh Road, Meerut, U.P. for the course in M.Ed. in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.

7. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
