#### **ORDER**

WHEREAS the institution namely SMT. SARLA PARSRAMURIA SHIKSHA SHASTRI MAHAVIDYALAYA, VILLAGE & POST - DUNDLOD, TEHSIL - NAWALGARH, DISTT. - JHUNJHUNU, RAJASTHAN has submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting Shiksha Shastri course of One year duration with an annual intake of 100 (one Hundred ) students .

- AND WHEREAS the Northern Regional Committee in its 132<sup>nd</sup> (second sitting ) & 148<sup>th</sup> meeting has decided to grant recognition under clause 7(9) & 7(11) of regulations 2007 respectively subject to appointment of qualified faculty whose methods of teaching is English in place of Shri G. Narayan Tripathi in compliance with the directions/orders passed by the Hon ble High Court of Rajasthan at Jaipur Bench in S.B.C.W.P. no. 12049/2008.
- AND WHEREAS Recognition order under clause 7(11) was issued with the following conditions on:30.08.2009:-
  - (a) That the order of recognition under clause 7(11) of regulations 2007 come into operation after appointment of qualified faculty whose methods of teaching is English in place of Shri G. Narayan Tripathi
  - Final out come of SLP filed by NCTE in the Hon'ble Supreme Court of India. (b)
  - That no admission of students shall be made till compliance of above point (C)
- AND WHEREAS the matter was placed before Emergency meeting of the Northern Regional Committee held on 2<sup>nd</sup> September 2009, the committee considered the legal opinion of the legal counsel of NRC Jaipur and subsequent order of Hon'ble High Court of Rajasthan at Jaipur Bench, as communicated by the legal counsel mentioning the direction of the Hon'ble High Court of Rajasthan at Jaipur Bench to pass an order regarding recognition by 04.09.2009, the committee decides to issue order under clause 7(11) of NCTE regulation, 2007 w.e.f. session 2008-2009.
- NOW. THEREFORE. in pursuance to the above orders, the recognition order is passed. In exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to SMT. SARLA PARSRAMURIA SHIKSHA SHASTRI MAHAVIDYALAYA, VILLAGE & POST - DUNDLOD, TEHSIL - NAWALGARH, DISTT. JHUNJHUNU, RAJASTHAN for conducting Shiksha Shastri Course of Secondary (level) of one year duration with an annual intake of 100 (One Hundred) students w.e.f the academic session 2008-09 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007. This order is subject to final out come of SLP filed by NCTE in the Hon'ble Supreme Court of India.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

- 7. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 8. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- 9. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- 10. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- 11. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- 12. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
  - · Copy of the Application Form
  - · Land and Building Particulars
  - Staff Profile
  - Recognition letter
  - Information for having fulfilled the norms & standard and other required conditions.
