

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Dayanand Danku Paraga Gyan Udai Mahavidyalaya, 128/28, 'E' block, Kidwai Nagar, Kanpur Nagar, U.P, had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting B.P.Ed Course of One year duration with an annual intake of 50 (Fifty Only) students on 30.12.2004.

- AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 143rd Meeting held on 27th to 29th June, 2009, the committee decided to seek clarification from the institution, accordingly clarification letter was issued vide letter no. F.NRC/NCTE/F-7/UP-1762/143 MEETING/2009/5556-57 Dated 06.07.2009.
- AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE, Jaipur on 20.08.2009 and the matter was placed before NRC in its 147th Meeting held on 16th to 17th August, 2009 and the committee decided to refuse the recognition for B.P.ED course of one year duration. Accordingly order was issued to the institution vide order no. F.NRC/NCTE/F73/UP-1762/147th Meeting/2009/8528-8534 dated 20.08.2009. The above said institution, thereafter preferred an appeal dated 25.08.2009 to the NCTE, New Delhi. under section 18 of the NCTE Act 1993 against the aforesaid order.
- AND WHEREAS after perusal of Jocuments, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was enough ground to accept the appeal directed to issue formal order in continuation to the earlier order dated 26.7.2006 Accordingly , the appeal was accepted and NRC's order dated 20.08.2009 was reversed, with direction to issue formal order in continuation of earlier order, vide its order no. F.NO. 89-943/2009 -APPEAL dated 06.11.2009.
- NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Dayanand Danku Paraga Gyan Udai Mahavidyalaya, 128/28, 'E' block, Kidwai Nagar, Kanpur Nagar, U.P for conducting B.P.ED course of Secondary (Level) of One year duration with an annual intake of 50 Students (Fifty only) students from the academic session 2006-2007 that to in continuation of the order dated 26.7.2007.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

- 8. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- 9. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- 10. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- 11. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- 12. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
 - Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - · Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.

13. In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
