- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- AND WHEREAS in its 132 menting held on 11-14 Sept. 2008 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 22.9.2008 to the applicant institution under provise to section 14(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- AND WHEREAS the applicant institution has not submitted representation . The original file of the institution as well as other documents and along with VTR and videography were again duly considered by Northern Regional Committee in its 140" meeting held on 25-26 April 2009 which came to the conclusion that recognition/ permission to the said institution be refused for the following reasons:
- The institute failed to submit the reply to the show cause notice issued by the office in stipulated time.
- NOW THEREFORE grant of recognition DISTRICT INSTITUTE OF EDUCATION AND TRAINING, ISKAUNA, SHAHARANPUR, U.P. for the course in BTC in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused,
