RESUSAL ORDER

WHEREAS DISTRICT INSTITUTE OF EDUCATION AND TRAINING, ISKAUNA, SHAHARANPUR, U.P. had applied for grant of recognition (UP - 1981) for BTC Course two years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 132nd meeting held on 11-14 Sept. 2008 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 22.9.2008 to the applicant institution under proviso to section 14(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

3. AND WHEREAS the applicant institution has not submitted representation. The original file of the institution as well as other documents and along with VTR and videography were again duly considered by Northern Regional Committee in its 140th meeting held on 25-26 April 2009 which came to the conclusion that recognition/ permission to the said institution be refused for the following reasons:

- The institute failed to submit the reply to the show cause notice issued by the office in stipulated time.

4. NOW THEREFORE grant of recognition DISTRICT INSTITUTE OF EDUCATION AND TRAINING, ISKAUNA, SHAHARANPUR, U.P. for the course in BTC in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused,
