## ORDER

WITEREAS PRD COLLEGE OF EDUCATION, VILL & POST- HARNAUL, DISTT-YAMUNANAGAR, HARYANA of recognition (HR-1743) for B.Ed course one years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constitute a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- 3. AND WHEREAS in its 138<sup>th</sup> Meeting held on 14<sup>th</sup> March to 16<sup>th</sup> March, 2009 the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution does not fulfill the requirements and issued a notice on 25.3.2009 to the applicant institution under provision to section 14(3) (b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf as under
  - The Government recommendation is negative.
  - . The land is not in the name of the institution.
  - CLU is not enclosed.
  - Building completion certificate issued by Sarpanch is without the resolution of Panchavat.
  - Sufficient number of computers for 100 students is not there.
  - No supporting documents (photocopy Stock registers) for the entry of equipments of different laboratories.
  - No supporting document in respect of hardware and software for language Lab.
- 4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 24.4.2009. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 141<sup>st</sup> Meeting held on 25<sup>th</sup> April to 26<sup>th</sup> April, 2009 the committee decided that recognition to the said institution be refused for following reasons.
  - Deficiencies communicated in the show cause notice issued by the office are not replied within stipulated period.
- 5 AND WHEREAS the committee decides to refuse recognition and retuen FDRs if submitted.
