**ORDER**

WHEREAS **D.I.E.T, Khosa Pando, Moga, Punjab** of recognition (PB-416) for ETT course Two years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constitute a Visiting Team to visit the Institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its **121<sup>st</sup> 2<sup>nd</sup> Sitting Meeting** held on **16<sup>th</sup> to 17<sup>th</sup> September 2007**, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant Institution issued conditional recognition to the applicant institution on **06.11.2007**.

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its **141<sup>st</sup> Meeting** held on **22<sup>nd</sup> May to 24<sup>th</sup> May 2009** the committee decided that recognition to the said institution be refused for following reasons.

- **The list of appointed Faculty as per NCTE Norms has not been submitted till date.**

5. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

6. NOW THEREFORE grant of recognition to **D.I.E.T, Khosa Pando, Moga, Punjab** for the course in **ETT** in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
