ORDER

WHEREAS **Shaheed Udham Singh Elementary Teacher Training Institution, Meham, Sunam, Sangrur, Punjab** of recognition (PB-479) for ETT course Two years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constitute a Visiting Team to visit the Institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 133rd Meeting held on 31st October to 01st November 2009 the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution issued conditional recognition to the applicant Institution on 03.12.2008.

4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 20.05.2009. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 141st Meeting held on 22nd May to 24th May 2009 the committee decided that recognition to the said institution be refused for following reasons.

- As per NCTE Norms for D.Ed. the Principal is over age.

5. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

6. NOW THEREFORE grant of recognition to **Shaheed Udham Singh Elementary Teacher Training Institution, Meham, Sunam, Sangrur, Punjab** for the course in ETT in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
