ORDER

WHEREAS SARSWATI COLLEGE OF EDUCATION, VPO- BUTANA, TEHSIL- GOHANA, DISTT.- SONEPAT, HARYANA of recognition (HR- 1481) for B.ED. course one years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constitute a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 138TH Meeting held on 14TH TO 16TH MARCH, 2009 the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution does not fulfill the requirements and issued a notice on 25.3.2009 to the applicant institution under provision to section 14(3) (b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf as under -

- The Government Recommendation is negative.
- The land is not in the name of the institution.
- CLU is not enclosed.
- The building plan is signed by sarpanch without the resolution of the panchayat.
- Building completion certificate is not issue by competent authority.
- The laboratories are ill equipped.
- Sufficient number of computers for 100 students is not there.
- NO supporting document in respect of hardware and software for language lab.

4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 23.04.2009 . The facts of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 141st Meeting held on 25th April to 26th April, 2009 the committee decided that recognition to the said Institution be refused for following reasons.

- State Government recommendation is negative.
- CLU Is issued by Sarpanch who is not competent authority.
- Land is not in the name of the Institution as required under Clause 8(7) of NCTE Regulation 2007.

6. NOW THEREFORE grant of recognition to **SARSWATI COLLEGE OF EDUCATION, VPO- BUTANA, TEHSIL- GOHANA, DISTT.- SONEPAT, HARYANA,** for the course in B.Ed in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of five lack vide no. *02792* and FDR of three lacks vide no. *02792* are returned herewith.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
