**ORDER**

WHEREAS SHRI SAI COLLEGE OF EDUCATION, VILL- TAMASPUR, POST- JHAJJAR, DISTT.- JHAJJAR, HARYANA. of recognition (HR- 958) for B.ED. course of one years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 138<sup>th</sup> Meeting held on 14<sup>th</sup> TO 16<sup>th</sup> MARCH, 2009 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution does not fulfill the requirements and issued a notice on 25.3.2009 to the applicant institution under provision to section 14(3) (b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf as under -

- The Government Recommendation is negative.
- The land is not in the name of the institution.
- CLU is not enclosed.
- Building completion certificate is not issue by competent authority.
- In addition to above the following are the observations of VT members.
  - (a) The members of VT were shown the building under construction on the campus of shree Sai Institute of Engineering and Tecnology.
  - (b) The items /equipments/materials/computers/ET equipments etc. placed before the team were arranged from some where as they did not match with the bills produced before the team.
  - (c) All books were managed from some where as no book had the seal of the college and accession number.

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE on 23.04.2009. The facts of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 141<sup>st</sup> Meeting held on 25<sup>th</sup> April to 26<sup>th</sup> April, 2009 the committee decided that recognition to the said institution be refused for following reasons.

- Deficiencies communicated in the show cause notice issued by the office are not replied within stipulated period.

5 AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

6. NOW THEREFORE grant of recognition to SHRI SAI COLLEGE OF EDUCATION, VILL- TAMASPUR, POST- JHAJJAR, DISTT.- JHAJJAR, HARYANA. for the course B. Ed. in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of five lakh vide no 437065 is returned herewith.

7. If the institution is not satisfied by the above order, they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
