ORDER

WHEREAS IPJ COLLEGE, VILLAGE- ISMALIA, POST- ISMALIA, PLOT NO - SAMPLA STREAT NO- SAMPLA, TESHIL- ROHTAK, DISTT- ROHTAK, HARYANA. of recognition (HR- 1614) for M.ED. course of one years (1) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 138th Meeting held on 14th TO 16th MARCH, 2009 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution does not fulfill the requirements and issued a notice on 25.3.2009 to the applicant institution under provision to section 14(3) (b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf as under:-

- The land is not in the name of the institution.
- CLU is not enclosed.
- Building completion certificate is not issued by competent authority.
- The built up area as per approved building plan for all the courses run by institution is far less than the area prescribed in NCTE norms.
- As per essential data sheet of VT report, the dimensions of different rooms as mentioned in it did not tally with the dimensions as indicated in the submitted building plan.
- As per VT report, library facility is not as per NCTE Norms. Photocopy of accession register is not enclosed.
- Sufficient number of computers of 125 students is not there.
- As Per VT report, internet facility for students and teachers is not there.
- As VT report, there is no language laboratory which is essential for B.Ed and D.Ed courses.
- The furniture is not sufficient as per VT report.
- No supporting documents (Photo copy stock registers) for the entry of equipments of different laboratories.

AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE by 23.04.2009. The facts of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 141st Meeting held on 25th April to 26th April,

2009 the committee decided that recognition to the said institution be refused for following reasons.


- Deficiencies communicated in the show cause notice issued by the office are not replied within stipulated period.

5 AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

6 NOW THEREFORE grant of recognition to IPJ COLLEGE, VILLAGE- ISMALIA, POST- ISMALIA, PLOT NO - SAMPLA STREET NO- SAMPLA, TESHIL- ROHTAK, DISTT- ROHTAK, HARYANA. for the course in M Ed. in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of five lakhs bearing no 003539 is returned herewith.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.


