ORDER

WHEREAS **SANT ROSHAN LAL DEGREE COLLEGE OF EDUCATION, VILLAGE- DHANI MAHU TEHSHIL- TOSHAM, DISTT- BHIWANI, HARYANA** has submitted application for recognition (HR- 735) of **MED.** course of one years (1) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its **134th Meeting held on 20TH TO 22TH November, 2006** the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution was issued clarification letter to the applicant institution on 01.12.2008 as under;-

- **PROFESSOR APPOINTED DOES NOT EXPERIENCE REGARDING TEACHING M.ED CLASSES NOT QUALIFIED.**
- **READER TEACHING EXPERIENCE CERTIFICATE REQUIRED.**

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. The matter was placed in **141st meeting** which was held on **22nd to 24th May, 2009.** The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:

- **The information required regarding qualification of Professor and Reader is not submitted.**



5 AND WHEREAS the committee decided to with draw the conditional recognition granted to the institution.

6. NOW THEREFORE grant of recognition to **SANT ROSHAN LAL DEGREE COLLEGE OF EDUCATION, VILLAGE- DHANI MAHU TEHSHIL- TOSHAM, DISTT- BHIWANI, HARYANA** for the course in **M.ED** is hereby with drawn.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
