## ORDER

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- 3. AND WHEREAS in its 134<sup>th</sup> Meeting held on 20<sup>TH</sup> TO 22<sup>TH</sup> November, 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution was issued clarification letter to the applicant institution on 01.12.2008 as under;-

  - . READER TEACHING EXPERIENCE CERTIFICATE REQUIRED.

The matter was placed in 141<sup>st</sup> meting which was held on 22<sup>nd</sup> to 24<sup>th</sup> May, 2009. The information required regarding qualification of Professor and Reader is not submitted.

- 6. NOW THEREFORE grant of recognition to SANT ROSHAN LAL DEGREE COLLEGE OF EDUCATION, VILLAGE- DHANI MAHU TEHSHIL- TOSHAM, DISTT- BHIWANI, HARYANA for the course in M.ED is hereby with drawn.
- 7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
