ORDER

WHEREAS VAISH COLLEGE OF EDUCATION, ROHTAK, HARYANA submitted an application for recognition (HR-303) of B.Ed ADD Course of two years (2) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- 3. AND WHEREAS In its 107th Meeting held on 26th -27th August, 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution was issued letter of conditional recognition on 27.08.2006 and clarification letter on 26.07.2007.
- 4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE by 22.05.2009. The matter was placed in 141st meting which was held on 22nd to 24th May, 2009, the original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:
 - The list of Faculty selected by dully constituted selection committee as per NCTE Norms is not submitted.
- 5 AND WHEREAS the committee decided to with draw the conditional recognition granted to the institution.



- NOW THEREFORE grant of recognition to SHARBATI COLLEGE OF EDUCATION, GAUSHALA ROAD, MOHINDERGARH, DISTT-MOHINDERGARH, HARYANA for the course in D.Ed ADD is hereby with drawn.
- 7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
