- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

AND WHEREAS in its 119TH (2ND SITTING) Meeting held on 04TH TO 05^{NO} AUGUEST, 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution was issued clarification letter on 06.09.2007.
- 4. AND WHEREAS the applicant Institution has not submitted representation to Northern Regional Committee, NCTE. The matter was placed in 141st meting which was held on 22nd to 24th May, 2009 The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:
