ORDER

WHEREAS **SARASWATI COLLEGE OF EDUCATION, C/O M/S SHIV BHOLEY ROLLER, FLOUR MILLS (P) LTD, 5TH K.M, STONE, DABRA ROAD, HISAR-125005, HARYANA** has submitted application for recognition (HR- 344) of B.ED. course of one years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS In its 107TH Meeting held on 26TH TO 27TH August, 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution was issued letter of conditional recognition on 27.08.2006. .
