## ORDER

WHEREAS SARASWATI COLLEGE OF EDUCATION, C/O M/S SHIV BHOLEY ROLLER, FLOUR MILLS (P) LTD, 5<sup>TH</sup> K.M, STONE, DABRA ROAD, HISAR-125005, HARYANA has submitted application for recognition (HR- 344) of B.ED. course of one years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- 3. AND WHEREAS In its 107<sup>TH</sup> Meeting held on 26<sup>TH</sup> TO 27<sup>TH</sup> August, 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant Institution, was satisfied that the applicant institution was issued letter of conditional recognition on 27.08.2006.

  - The list of Faculty selected by dully constituted selection committee as per NCTE Norms is not submitted.
- 5 AND WHEREAS the committee decided to with draw the conditional recognition granted to the institution.

- NOW THEREFORE grant of recognition to SARASWATI COLLEGE OF EDUCATION, C/O M/S SHIV BHOLEY ROLLER, FLOUR MILLS (P) LTD, 5<sup>TH</sup> K.M, STONE, DABRA ROAD, HISAR-125005, HARYANA. for the course in B.ED is hereby with drawn.
- 7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
