RESUSAL ORDER

WHEREAS UNITY DEGREE COLLEGE, POST - BARAWAN KALAN, KAKORI, LUCKNOW, U.P. had applied for grant of recognition (UP - 2269) for M.ED. Course one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 137" meeting held on 28" FEB TO 1ST MARCH 2009 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 12 3 2009 to the applicant institution under proviso to section 14(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 3. AND WHEREAS the applicant institution had submitted representation dated 28.4.2009. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by Northern Regional Committee in its 139th meeting held on 10th 12th April 2009 which came to the conclusion that recognition/ permission to the said institution be refused for the following reasons:
- · The institution did not remove the deficiencies in stipulated time.
- NOW THEREFORE grant of recognition UNITY DEGREE COLLEGE, POST BARAWAN KALAN, KAKORI, LUCKNOW, U.P. for the course in M.Ed. in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
