RESUSAL ORDER

WHEREAS DISTRICT INSTITUTE OF EDUCATION AND TRAINING, PATEHARA KALAN, MIRZAPUR, U.P. had applied for grant of recognition (UP-1033) for B.ED. ADDITIONAL INTAKE one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the Institution and the visiting team had since submitted its report.
- AND WHEREAS in its 73" meeting held on 12 December 2003, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 13.12.2003 to the applicant institution under proviso to section 14(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf. The institution has submitted reply and place in NRC in its 75 meeting and committee directed that the concerned DIETs and the State Govt, of U.P. may be requested to submit proof and compliance be sent within one months from the date of issue of the letter from NRC. Letter issued on 29.1,2004. The institution has submitted reply and place in NRC in its 87" meeting and committee decided to convey to the DIET that the deficiencies be removed nor or before 25th Feb. 2005 and the same be communicated to this office with documentary evidence. No reply received from the institution and matter place in NRC in its 101st meeting and committee decided that a show cause notice under section 15 of the NCTE Act be served to the institution as to why the application should not be rejected on account of non submission of the reply and Issue scn dated 17.3.2005. No reply received from the institution. The case was again place in NRC in its 119" meeting and committee decided to issued final sch and letter issued on 2.11.2007.
- 3. AND WHEREAS the applicant institution had not submitted representation. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by Northern Regional Committee in its 140<sup>th</sup> intesting held on 25-26. April 2009 which came to the conclusion that recognition/ permission to the said institution be refused for the following reasons:
- · The institution did not remove the deficiencies in stipulated time.
- 4. NOW THEREFORE grant of recognition district institute of education and transition pateriaga Kalan, MIRZAPUR, U.P. for the course in BEC ADDITIONAL INTAKE in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
