**ORDER**

WHEREAS **HARYANA COLLEGE OF EDUCATION, HOUSE NO -1385 ESTATE, JIND, DISTT- JIND, HARYANA** has submitted application for recognition (HR- 321) of **DED**. course of two years (2) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the Institution and the visiting team had since submitted its reports.

3. AND WHEREAS In its 107<sup>STH</sup> Meeting held on 07<sup>TH</sup> TO 09<sup>TH</sup> November, 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant Institution, was satisfied that the applicant institution was issued letter of conditional recognition on 09.09.2006 and clarification letter was issued on 12.11.2007.

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. The matter was placed in 141<sup>ST</sup> meeting which was held on 22<sup>ND</sup> to 24<sup>TH</sup> May, 2009 The original file of the Institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:

- The list of Faculty selected by dully constituted selection committee as per NCTE Norms is not submitted.


5. AND WHEREAS the committee decided to with draw the conditional recognition granted to the institution.
