## RESUSAL ORDER

WHEREAS NAND KISHORE SINGH DEGREE COLLEGE, DHANGHA CHAKA, NAINI, ALLAHABAD, U.P had applied for grant of recognition (UP - 2862) for B.Ed. Course one years(s) duration under section 14 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 135 meeting held on 29-30 December 2008the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 17.1.2009 to the applicant institution under proviso to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf:
- 3. AND WHEREAS the applicant institution has not submitted representation. The original file of the institution as well as other documents and along with VTR and videography were again duly considered by Northern Regional Committee in its 140° meeting held on 25-26 April 2009 which came to the conclusion that recognition/ permission to the said institution be refused for the following reasons:
- The institute failed to submit the reply letter dated 19.2.2007 issued by the office in stipulated time.
- NOW THEREFORE grant of recognition NAND KISHORE SINGH DEGREE COLLEGE, DHANUHA CHAKA, NAINI, ALLAHABAD, U.P. for the course in B.ED. In term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
