RESUSAL ORDER

WHEREAS R.S.M.P. DEGREE COLLEGE, RAI ASKARANPUR, AZADNAGAR, BADGANWA, KUNDA, PRATAPGARH, U.P. had applied for grant of recognition (UP - 2658) for B.ED. Course one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 132nd meeting held on 11th -14th September 2008 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a show cause notice on 23.9.2008 to the applicant institution under proviso to section 14(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf. The institution has submitted reply of show cause notice placed in NRC in its 138 meeting and NRC decided to seek clarification.

3. AND WHEREAS the applicant institution had submitted representation dated 06.4.2009. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by Northern Regional Committee in its 139th meeting held on 10th -12th April 2009 which came to the conclusion that recognition/ permission to the said institution be refused for the following reasons:

- Submitted CLU is not from competent authority on prescribed format.
- The deficiency in respect of computer and language lab is not removed.

4. NOW THEREFORE grant of recognition BABA SARVAJEET GIRI MEMORIAL MAHAVIDYALAYA, KATRA GULAB SINGH, PRATAPGARH, UTTAR PRADESH for the course in B.Ed. in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.

5. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
