ORDER

WHEREAS DEPARTMENT OF PHYSICAL EDUCATION, CHAUDHARY, DEVI LAL UNIVERSITY, SIRSA, HARYANA has submitted application for recognition (HR- 877) of M.P.ED. course of one years (1) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 125TH Meeting held on 21ST TO 22ND JANUARY, 2008 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution was issued conditional recognition on 25.01.2008.

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. - The list of selected Faculty by dully constituted selection committee is not submitted.


5 AND WHEREAS the committee decided to with draw the conditional recognition granted to the institution.
