## ORDER

WHEREAS SHALOM HILLS INSTITUTE OF EDUCATION SUSHENT LOK, BLOCK-E, GURGAON, HARYANA has submitted application for recognition (HR-1031) of C.ED course of two years (2) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- 3. AND WHEREAS in its 132<sup>TH</sup> Meeting held on 11<sup>TH</sup> TO 14<sup>TH</sup> SEP, 2008 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution does not fulfill the requirements and issued a notice on 17.09.2008 to the applicant institution under provision to section 14(3) (b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf as under -
  - 1. THE SIZE OF CLASS ROOM IS LESS
  - 2. DEMARCATED MAP SHOWING BUIDING PARTS TO BE USED FOR CED
- 4. AND WHEREAS the matter was again placed in 138th meeting of Northern Regional Committee which was **held on 14**<sup>TH</sup> **TO 16**<sup>TH</sup> **March, 2009** the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution does not fulfill the requirements and issued a clarification letter on 25.03.2009 as under
  - The building map is not approved by the competent authority.
  - The demarcated area in the area in the map does not show the entire built up space required for C.Ed
  - The land is not the name of the institution
  - The Haryana State Govt recommendation is negative.
- 5. AND WHEREAS the applicant Institution has not submitted representation to Northern Regional Committee, NCTE. The facts of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 141<sup>st</sup> Meeting held on 22<sup>nd</sup> May to

- Deficiencies communicated in the show cause notice issued by the office are not replied within stipulated period.
- 6 AND WHEREAS the committee decided to refuse recognition and return FDRs if submitted.
- 7. NOW THEREFORE grant of recognition to SHALOM HILLS INSTITUTE OF EDUCATION SUSHENT LOK, BLOCK-E, GURGAON, HARYANA for the course in C. Ed in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of five lakks bearing no 461400PR00000599 and FDR of three lakks bearing no 461400PR00000580 are returned herewith.
- 8 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
