### ORDER

WHEREAS K.C College of Education, VPO- Ganaur, Tehsil- Ganaur, District- Sonapat, Haryana of recognition (HR- 1711) for B.ED course of one years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS In its 138<sup>TH</sup> Meeting held on 14<sup>TH</sup> TO 16<sup>TH</sup> MARCH, 2009 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution does not fulfill the requirements and issued a notice on 25.3.2009 to the applicant institution under provision to section 14(3) (b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf as under -

- The land is not in the name of the institution.
- CLU is not enclosed.
- Building Completion certificate is not enclosed.
- Sufficient number of computers for 100 students is not there.
- No supporting documents (Photo copy Stock Registers) for the entry of equipments of different laboratories.
- No supporting documents in respect of hardware and software for language lab.

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. The facts of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 141<sup>st</sup> Meeting held on 22<sup>nd</sup> May to 24<sup>th</sup> May 2009 the committee decided that recognition to the said institution be refused for following reasons.

- Land is on lease from private party which is not according to Clause 8(7) of NCTE Regulation 2007.

5. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

6. NOW THEREFORE grant of recognition to K.C College of Education, VPO- Ganaur, Tehsil- Ganaur, District- Sonapat, Haryana for the course in B. Ed in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of five lakhs bearing no 795281 and FDR of three lakhs bearing no 403821 are returned herewith.



7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
